Section 2 of the Declaration of Condominium of Howell Park Condominium Association, Inc is hereby amended so that as amended it will add the following

2.7 WASTE DRAIN LINES include

- (a) "Kitchen and bathroom waste drain lines" means those waste drain lines that extend from the unit to the main waste drain line
- (b) "Main waste line" means the waste drain line that extends throughout the condominium property and services each individual unit through the kitchen and bathroom waste drain lines. The main waste line is a common element to be maintained by the Association.

Section 5 1(b) of the Declaration of Condominium of Howell Park Condominium Association, Inc is hereby amended so that as amended it will add the following

- 5 1(b)5 To maintain, repair and replace at unit owners expense the kitchen and bathroom waste drain lines extending from the unit to the main waste drain lines
